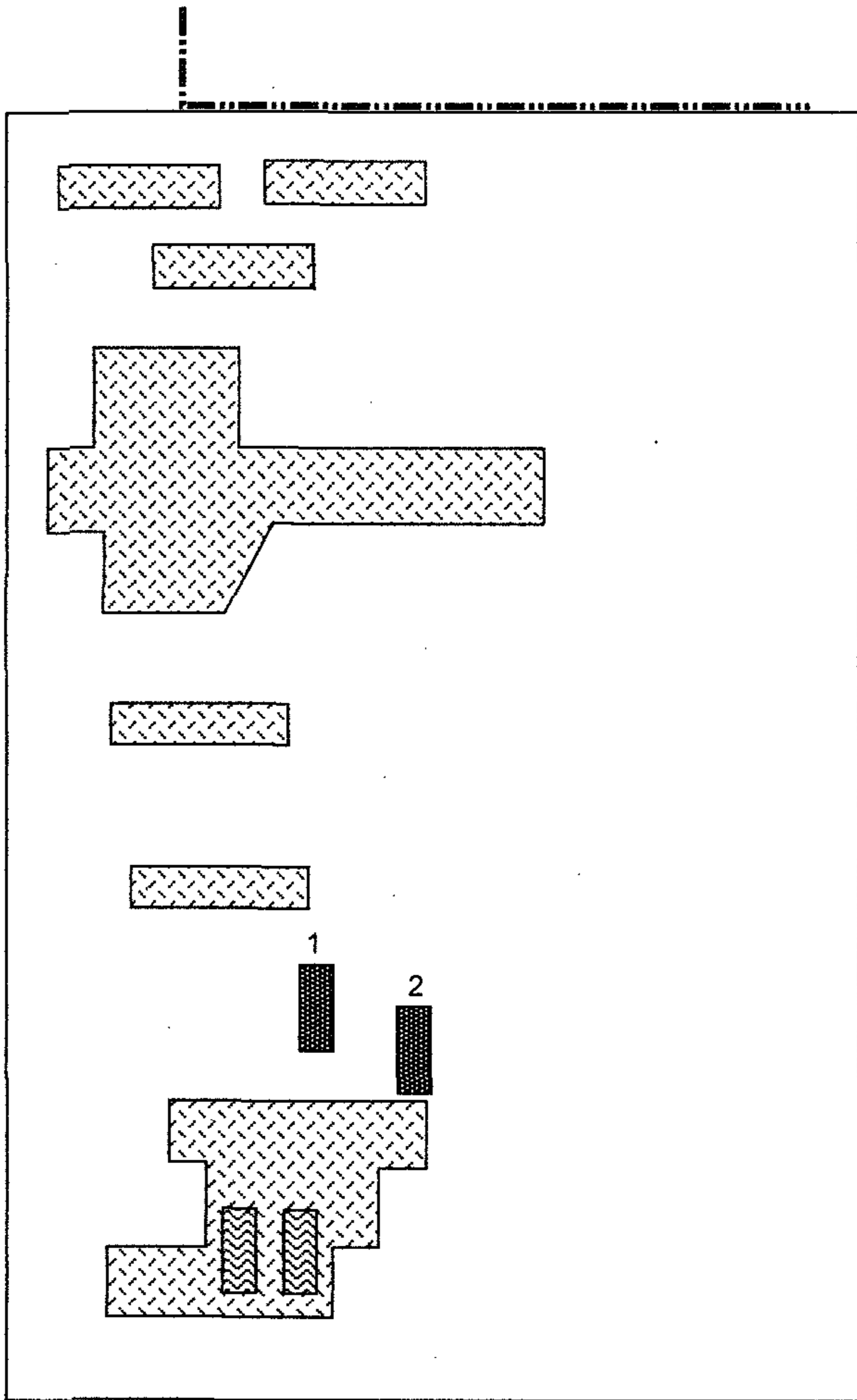

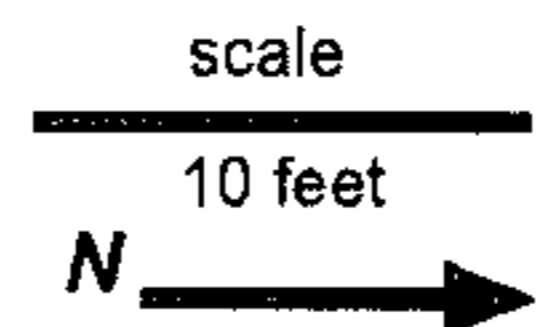

Markham Memorial Gardens Limits

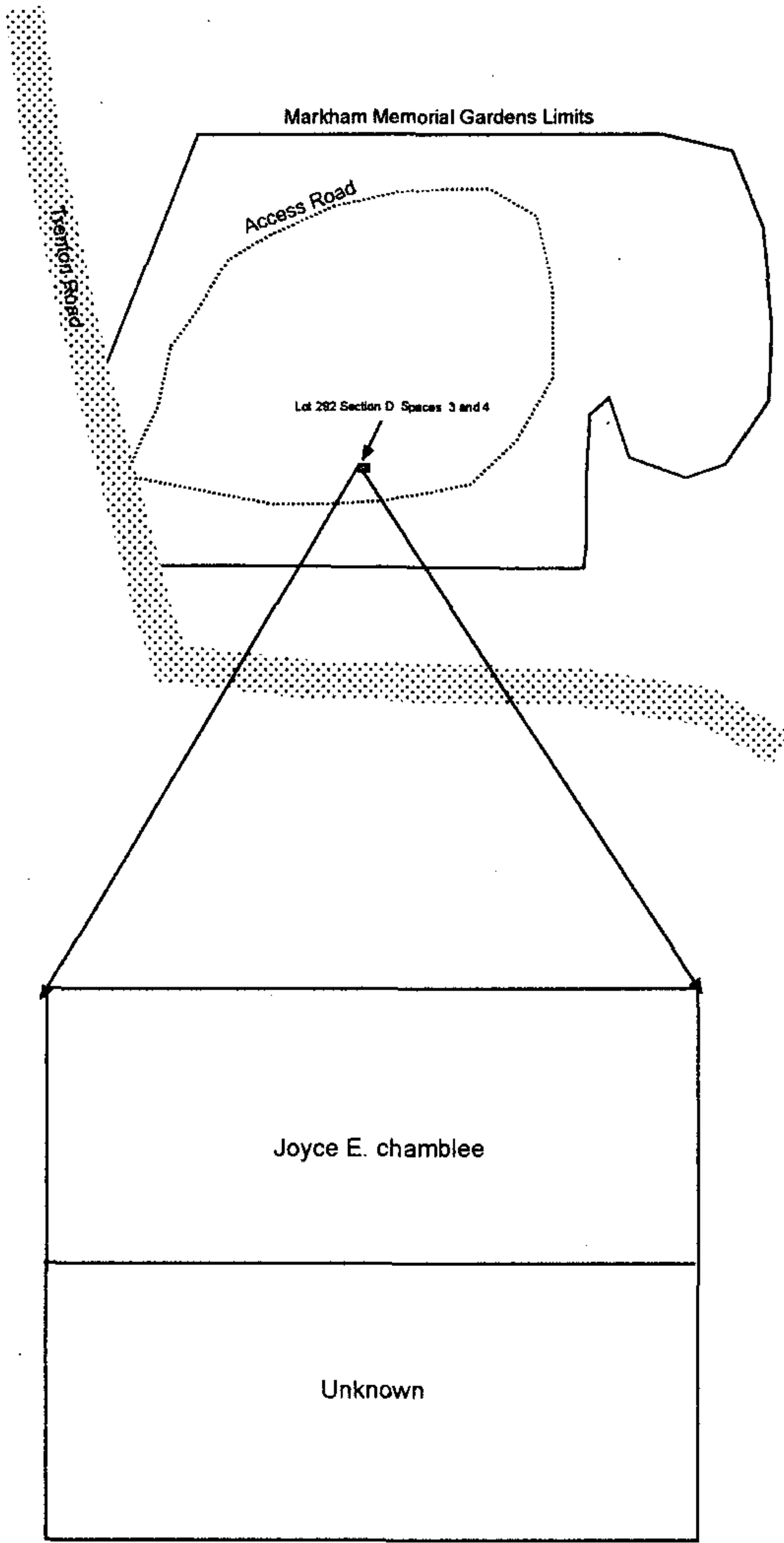
